ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Kotaiche & Associates, Inc., and the principal address and principal place of business is P.O. Box 20708, St. Petersburg, Florida 33742.

ARTICLE II - REGISTERED OFFICE AND AGENT
