The undersigned, for the purpose of forming a corporation under the State of Florida's General Corporation Act hereby adopts the following Articles of Incorporation:

**ARTICLE ONE
NAME AND
PRINCIPAL OFFICE ADDRESS**

The legal name of this corporation is RICKARD TESTING & CONSULTING, INC. its principal office is located at 2750 North 29th Avenue, Suite 115, Hollywood, Florida 33020-1945.

**ARTICLE TWO
DURATION**

The term of existence of the corporation is perpetual. The time of commencement of the corporate's existence shall be the time of the filing of the Articles of Incorporation by the Department of State.

**ARTICLE THREE
PURPOSE**

The corporation is organized for the purpose of the transaction of any and all lawful business for which corporation may be incorporated under the Florida Corporation Act.

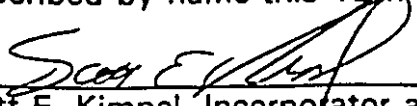

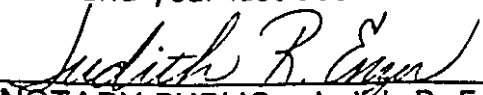

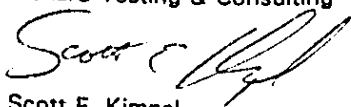
