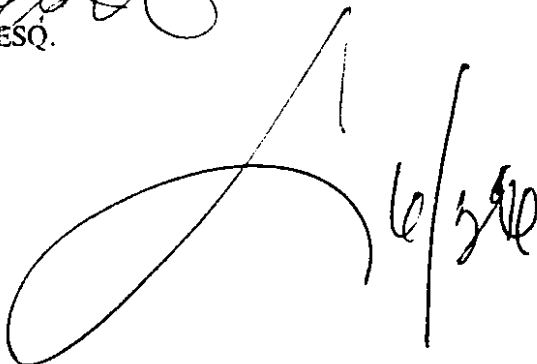

ARTICLE I - NAME

The name of this corporation is APOLLO ENTERTAINMENT CORP.

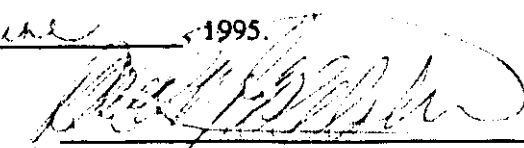
ARTICLE IX - BYLAWS

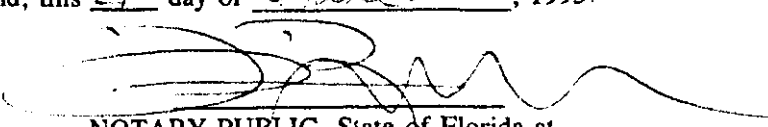

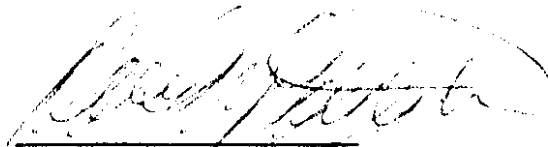
