ARTICLES OF INCORPORATION
OF

GASKETHAUS, INC.

ARTICLE I
NAME

The name of the corporation is: GASKETHAUS, INC.. at 3750 N.W. 28 Street, Bay 413, Miami, Fla. 33142

ARTICLE II
DURATION

This corporation shall have perpetual existence.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV
CAPITAL STOCK

This corporation is authorized to issue Five Thousand shares of One Dollar par value common stock, which shall be designated "Common Shares".

SECTION 2. VOTING RIGHTS

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE XIII

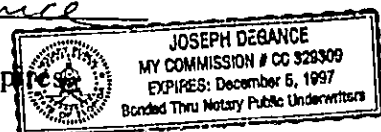


DESIGNATION OF RESIDENT AGENT
