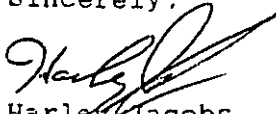

ARTICLES OF INCORPORATION
OF
GENERAL TELECOMMUNICATIONS MONITORING, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is GENERAL TELECOMMUNICATIONS MONITORING, INC.

ARTICLE II: DURATION

The Corporation shall exist until terminated.

ARTICLE III: PURPOSE

The purpose of the corporation and the objects and aims of the corporation shall be to engage in the business of providing telecommunications monitoring services to the general public.

ARTICLE IV: CAPITAL STOCK

The corporation shall have the authority to issue and sell capital stock of any class or classes, and to determine the rights and preferences of such stock.

ARTICLE V: SECTION 1244 STOCK

The corporation and the equity holders shall be eligible to elect a person to be the representative of the corporation for the purpose of Section 1244 of the Internal Revenue Code.

ARTICLE VI: INITIAL REGISTERED OFFICE AND AGENT

The post office address of the Corporation's initial registered office is 2119 MAIN ST. DUNEDIN FL. 34698 and the name of its initial registered agent at such address is DAWN L. CRIMMINS. The Board of Directors may from time to time move the registered office to any other address in the State of Florida.

ARTICLE VII: INITIAL DIRECTORS

The initial Board of Directors shall consist of three Directors whose names and offices shall be as follows:

We shall continue until the first annual meeting of the shareholders and until our successors are chosen. We may be elected, re-elected, removed, or removed from office for cause.

ARTICLE VIII: INCORPORATOR

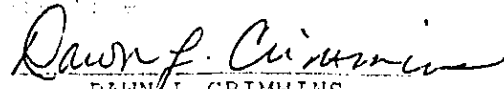

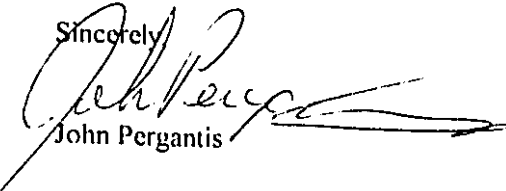
Dear Steve,
