Articles of Incorporation

Profix, Inc.

Article I

The name of the corporation is: **Profix, Inc.**

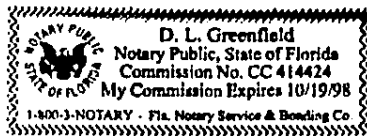



