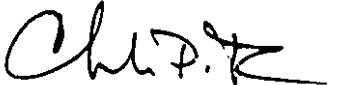

OF  
BOWLING PROMOTIONS UNLIMITED, INC.**

**ARTICLE I - NAME**

The name of this Corporation is Bowling Promotions Unlimited, Inc.

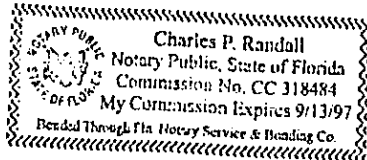
