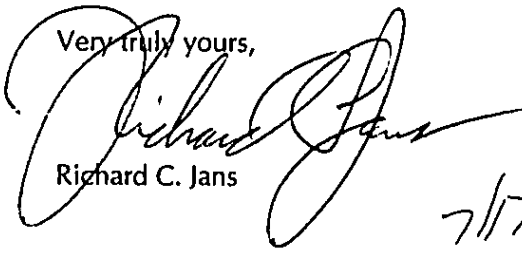

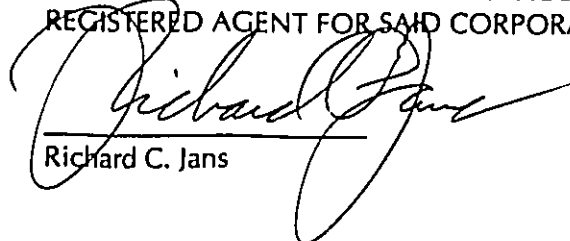

The name of this corporation is Tradeshow Exhibits & Displays Co.

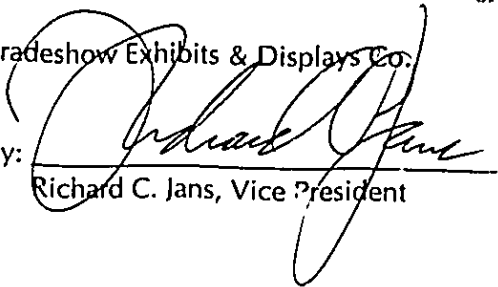
