The corporation shall have authority to issue 100 shares, all of one class, of 1 par value.



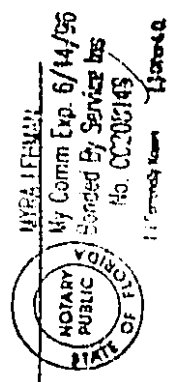
