

ARTICLE I - NAME

The name of this corporation is MCS - MIAMI CONSTRUCTION SERVICE CORP.

This Corporation reserves the right to amend or repeal any provision contained in these articles of incorporation, or any amendment hereto, and any right conferred upon the chareholders is subject to this reservation.
