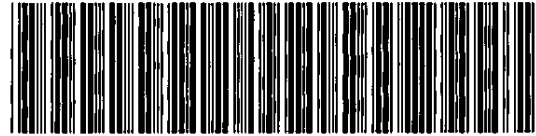

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to Section 607.1006 of the Florida Statutes, MICHAEL M. GUTIERREZ, M.D., P.A. (the "Corporation"), a corporation organized and existing under the laws of the State of Florida, under Document Number P95000060797, filed in the office of the Secretary of State on August 7, 1995, certifies as follows:

1. The sole director and shareholder of the Corporation considered amending the Articles of Incorporation in order to change the name, and after discussion, it was

RESOLVED, that the Articles of Incorporation of MICHAEL M. GUTIERREZ, M.D., P.A. be amended to change the name from MICHAEL M. GUTIERREZ, M.D., P.A. to MID-FLORIDA DERMATOLOGY ASSOCIATES, P.A., and that Article I shall be amended to read in its entirety as follows:

"ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be MID-FLORIDA DERMATOLOGY ASSOCIATES, P.A."

2. These Articles of Amendment were approved by the sole director of the Corporation and by the sole shareholder of the Corporation by joint written action dated June 29, 2006, which is sufficient for approval.
