

The undersigned, pursuant to Section 607.1006 (1996) of the Florida Business Corporation Act, hereby executes the following Articles of Amendment of the Articles of Incorporation of the above-named corporation, filed with the Department of State on August 17, 1995, Charter # P95000064061, as follows:

- 1. The name of the corporation in the Articles of Incorporation of which are hereby amended is BY OWNER ONLINE, INC.
- 2. Article I on page 1 of the Articles of Incorporation of the above-named corporation is hereby revoked and the following is substituted in its place:

#### ARTICLE I

The name of this corporation is BOOL, INC.

- 3. The foregoing Amendment was adopted by the sole shareholder of the corporation, in accordance with Section 607.1003 (1995), Florida Statutes, on Sephender 50, 1996. The outstanding share certificate of this corporation shall be exchanged for share certificates bearing the new name of the corporation which certificates shall set forth the same number of shares as the currently issued share certificates.

- 5. In every other respect, I hereby confirm and republish the said Articles of Incorporation as filed with the Department of State on August 17, 1995.
