hereby makes, subscribes, acknowledges and adopts the following
Articles of Corporation for the purposes of forming a corporation
under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be ADVANTAGE
ADVERTISING & PUBLISHING, INC. The principal place of business of

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing
upon the filing of these Articles of Incorporation by the Department



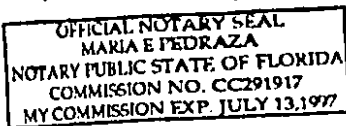


