ARTICLES OF INCORPORATION OF

DS LANDSCAPE & EXOTIC IMAGES, INC.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of incorporation for such corporation:

ARTICLE 1 - NAME

The name of this Corporation is: DS LANDSCAPE & EXOTIC IMAGES, INC.

ARTICLE 31 - ADDRESS

The street address of the usual principal office and the mailing address of the corporation is: 12350 S.W. 184 Street, Miami, Florida 33177.

ARTICLE III - NUMBER OF SHARES

The number of shares the corporation is authorized to issue is 1,000 shares of common stock having \$1.00 par value per share.

ARTICLE IV - DURATION

The period of duration of this Corporation is perpetual.

ARTICLE V - NATURE OF BUSINESS

The purposes for which the Corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act and other incorporation laws of the State of Florida and to carry on in any capacity any business or trade deemed legal in the State of Florida or any other state, country, territory or nation.

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder of this corporation shall have the first right to purchase shares (and securities convertible and shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares the shareholder holds at the time of issue bears to the total number of shares outstan exclusive of any treasury shares. This right shall be deemed waived by any shareholder does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting the shareholder to exercise his or her pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

ARTICLE VII - RIGHTS UPON LIQUIDATION OR DISSOLUTION

In the event of any voluntary or involuntary dissolution, liquidation or winding up of this corporation, the holders of record of the common shares shall receive a ratable distribution of the assets of the corporation.

ARTICLE VIII - DIRECTORS/OFFICERS

This Corporation shall have two (2) Directors initially. The number of Enectors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one (1).
