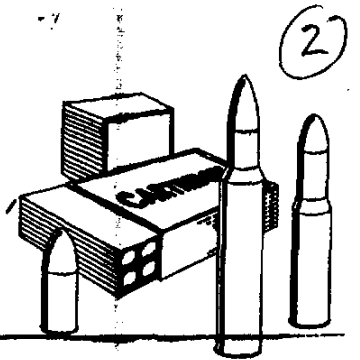

On July 9, 1998, I received a letter indicating it was a 2nd notice that my profit corporation annual report had not been filed. I most certainly would have been aware of the letter and mailed a check to you for the renewal.
