ARTICLE I. - NAME

The name of this Corporation is STADIA CORPORATION.

ARTICLE II. - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III. - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV. - PRINCIPAL OFFICE

The principal place of business of the corporation is 1386 South First Street, Lake City, Florida 32025, and the mailing address of this corporation is Post Office Box 847, Lake City, Florida 32056.

ARTICLE V. - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is One Hundred Thousand (100,000.00) shares of common stock.

ARTICLE VI. - INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this Corporation shall be 1386 South First Street, Lake City, Florida 32025, and the initial registered agent of this Corporation at such office shall be DONALD M. 




