BY A CONTRACT OF STATE OF STAT

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE - NAME AND ADDRESS

The name of the corporation shall be Urs Art Studio Gallery, Inc. The principal place of business of this corporation shall be 802 North Federal Hwy, Boynton Beach, Florida 33435.

The term of the corporation's existence is perpetual.
