ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as Incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

FIRST

The name of the corporation is Contech Restoration Services, Inc.

SECOND

The period of its duration is perpetual.

THIRD

The purpose of the corporation is to restore commercial and residential properties damaged due to casualty and such other activities as may from time to time be specifically found by the Board of Directors to be suitable.

FOURTH

The aggregate number of authorized shares is 5000.

FIFTH

The corporation will not commence business until at least 1000 dollars have been received by it as consideration for the issuance of shares.

SIXTH

Cumulative voting of shares of stock are not authorized.
