The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

## ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be HURT ENTERPRISES, INC. and the principal place of business shall be 101 Candace Drive, Fern Park, Florida 32730.
