For the purpose of forming a corporation under the Florida Business Corporation Act, the undersigned incorporators adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

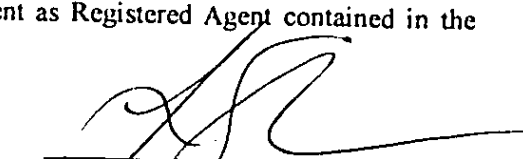
