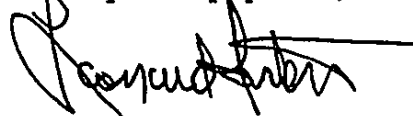

FIRST: The name of the corporation is LDA Litigation Services, Inc.

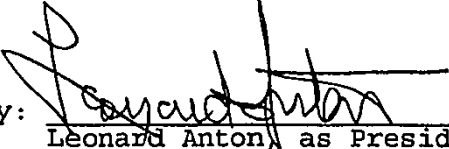
SECOND: The following amendment to the Articles of Incorporation was adopted by the corporation:

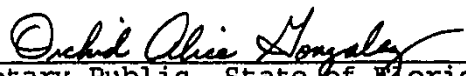
