



ARTICLES OF AMENDMENT GROVE CORPORATE, INC.

ALGARIAN PAR SOLES OF Pursuant to Florida Statutes Sections 607.1003 and 607.1006, the Incorporation of the above-referenced Corporation are amended as follows:

Article II - of the Articles of Incorporation is hereby deleted in its entirety, and in lieu thereof, the following is added:

The nature of the business and of the purposes to be conducted and promoted by the Corporation is to engage solely in the activity of acting as a general partner of a limited partnership whose purpose is to own, hold, sell, assign, transfer, operate, lease, mortgage, pledge and otherwise deal with certain parcels of real property, together with all improvements located thereon, in the City of Lakeland, State of Florida (the "Property"). The Corporation shall exercise all powers enumerated in the General Corporation Law of Florida necessary or convenient to the conduct, promotion or attainment of the business or purposes otherwise set forth herein.

Article VII - of the Articles of Incorporation is hereby deleted in its entirety, and in lieu thereof, the following is added:

- The Corporation shall only incur or cause the partnership to only incur indebtedness in an amount necessary to acquire, operate and maintain the Property. For so long as any mortgage lien in favor of Wachovia Bank, National Association, or its successors or assigns (the "First Mortgage") exists on any portion of the Property, the Corporation shall not and shall not cause the partnership to incur, assume, or guaranty any other indebtedness. For so long as the First Mortgage exists on any portion of the Property and the partnership remains owner of the Property, the Corporation: (i) shall not and shall not cause the partnership to dissolve or liquidate, (ii) shall not and shall not cause the partnership to consolidate or merge with or into any other entity, or convey or transfer its properties and assets substantially as an entirety or transfer any of its beneficial interests to any entity, (iii) shall not voluntarily commence a case with respect to itself or cause the partnership to voluntarily commence a case with respect to itself, as debtor, under the Federal Bankruptcy Code or any similar federal or state statute without the unanimous consent of the board of directors, and (iv) shall not materially amend the certificate of incorporation or By-Laws of the Corporation or the partnership agreement of the partnership without first obtaining approval of the mortgagee holding the First Mortgage on any portion of the Property.
- Any indemnification of the Corporation's directors and officers shall be fully subordinated to any obligations respecting the partnership or the Property (including, without limitation, the First Mortgage) and such indemnification shall not constitute a claim against the Corporation or the partnership in the event that cash flow in excess of amounts necessary to pay holders of such obligations is insufficient to pay such obligations.

- C. For so long as the First Mortgage exists on any portion of the Property, in order to preserve and ensure its separate and distinct corporate identity, in addition to the other provisions set forth in the certificate of incorporation, the Corporation shall conduct its affairs in accordance with the following provisions:
- 1. It shall establish and maintain an office through which its business shall be conducted separate and apart from those of its parent and any affiliate or shall allocate fairly and reasonably any overhead for shared office space.
- 2. It shall maintain corporate records and books of account separate from those of its parent and any affiliate.
- 3. Its board of directors shall hold appropriate meetings (or act by unanimous consent) to authorize all appropriate corporate actions.
 - 4. It shall observe all corporate formalities.
 - 5. It shall not commingle assets with those of its parent and any affiliate.
 - 6. It shall conduct its own business in its own name.
 - 7. It shall maintain financial statements separate from its parent and any affiliate.
- 8. It shall pay any liabilities out of its own funds, including salaries of any employees, not funds of its parent or any affiliate.
 - 9. It shall maintain an arm's length relationship with its parent and any affiliate.
- 10. It shall not guarantee or become obligated for the debts of any other entity, including its parent or any affiliate, or hold out its credit as being available to satisfy the obligations of others.
- 11. It shall use stationery, invoices and checks separate from its parent and any affiliate.
- 12. It shall not pledge its assets for the benefit of any other entity, including its parent and any affiliate.
 - 13. It shall hold itself out as an entity separate from its parent and any affiliate.

For the purpose of this Article VII, the following terms shall have the following meanings:

"affiliate" means any person controlling or controlled by or under common control with the parent, including, without limitation (i) any person who has a familial relationship, by blood, marriage or otherwise with any director, officer or employee of the Corporation, its parent, or any affiliate thereof and (ii) any person which receives compensation for administrative, legal or

accounting services from this Corporation, its parent or any affiliate. For purposes of this definition, "control" when used with respect to any specified person, means the power to direct the management and policies of such person, directly or indirectly, whether through the ownership of voting securities, by contract or otherwise; and the terms "controlling" and "controlled" have meanings correlative to the foregoing.

"parent" means with respect to a Corporation, any other corporation owning or controlling, directly or indirectly, fifty percent (50%) or more of the voting stock of the Corporation.

"person" means any individual, corporation, partnership, limited liability company, joint venture, association, joint stock company, trust (including any beneficiary thereof) unincorporated organization, or government or any agency or political subdivision thereof.

Article IX - of the Articles of Incorporation is hereby deleted in its entirety.

Article X - of the Articles of Incorporation is hereby deleted in its entirety.

- 2. The foregoing amendments were adopted as of October 21, 2002 by a Resolution of all of the Directors and Shareholders entitled to vote on the amendment, and such votes of approval was sufficient for approval.
- 3. The amendment does not provide for an exchange, reclassification, or cancellation of stock.
- 4. The Secretary of State is hereby requested to approve and file these Articles of Amendment in accordance with Chapters 607, Florida Statutes.
