PAWLOWSKI, CLIFFORD & BREWER, P.A.

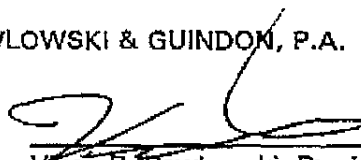
