The above named entity, Nelson & Levine, P.A., submitted its 2003 For Profit Corporation Uniform Business Report ("UBR") early this year. The UBR was filed along with a check dated February 19, 2002 made payable to the Florida Department of State (the "Department") in the amount of \$150.00.
