These Articles of Incorporation for Kirkland Properties, Inc. shall be effective the 1st day of January, 1996.

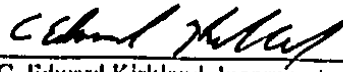
ARTICLE VII - BYLAW AMENDMENT

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

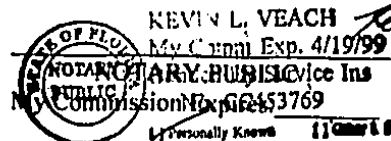

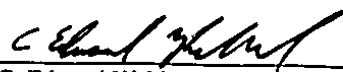
