ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Star Investments, Inc., and the principal address and principal place of business is 700 Tyrone Blvd., St. Petersburg, Florida.

ARTICLE II - REGISTERED OFFICE AND AGENT
