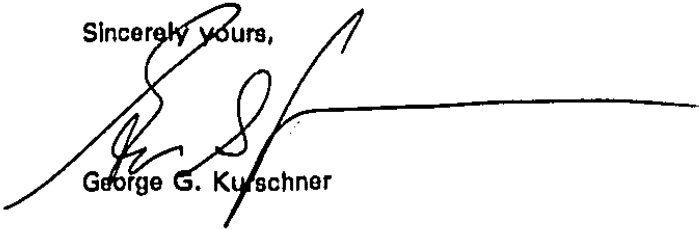

ARTICLE I

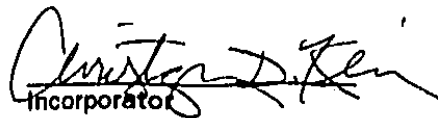

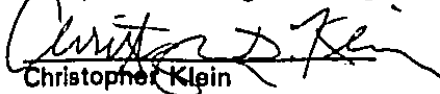
