**ARTICLES OF INCORPORATION
OF**

JAY M. FISHER, P.A.

ARTICLE I - NAME

The name of this corporation is Jay M. Fisher, P.A.

ARTICLE II - DURATION

The corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III - PURPOSE

The corporation is organized for the following purposes: To Practice Law, To transact any and all business permitted under the laws of the United States and of this State pursuant to Chapter 607, Fla. Stat.

ARTICLE IV - POWERS

The corporation shall have all the corporate powers enumerated in the Florida Business Corporation Act.

ARTICLE V - CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which shall be designated "common shares."

**ARTICLE VI - PRINCIPAL OFFICE; REGISTERED OFFICE AND AGENT;
MAILING ADDRESS**

The street address of the principal office and initial registered office designated by the corporation is: 982 Douglas Avenue, Suite 100, Altamonte Springs, Florida 32714, and the name of the initial registered agent designated by the corporation at this address is: Jay Martin Fisher. ARTICLE VIII - BY-LAWS

The power to adopt, amend or repeal by-laws shall be vested in the Board of Directors, subject to the power of the shareholders to repeal or amend any by-laws adopted by the Board of Directors. The shareholders also reserve the concurrent power to adopt by-laws and to prescribe in any by-laws that such by-laws shall not be amended or repealed by the Board of Directors.

The corporation elects to have preemptive rights, subject and pursuant to the provisions and limitations set forth in section 607.0630, Fla. Stat. (1989).
