ARTICLES OF INCORPORATION OF CHASTAIN-MILLER FARMS, INC.

FILED 96 JM II AM II: 55

The undersigned incorporator, for the purpose of forming a corporation under the order of Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I

The name of this Corporation shall be Chastain-Miller Farms, Inc.

Article II

The principal place of business and mailing address of this Corporation shall be:

Article III

The general nature of the business to be transacted by this Corporation is any and all business permitted under the laws of the State of Florida.

Article IV

This Corporation shall commence upon the filling of these Articles of Incorporation, and shall have perpetual existence.

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having a par value of One Dollar (\$1.00) per share.
