## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

INTERNET COMMUNICATION NETWORK, CORP.

Pursuant to Section 607.1006 of the Florida Business Corporation Act, INTERNET COMMUNICATION NETWORK, CORP., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), the Articles of Incorporation of which were initially filed with the Department of State of the State of Florida on January 12, 1996, DOES HEREBY adopt the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of this Corporation is INTERNET COMMUNICATION NETWORK, CORP.
- 2. Article I of the Corporation's Articles of Incorporation is hereby amended to read as follows:

## "ARTICLE I

The name of this Corporation is FUSIVE.COM, CORP."
