ARTICLE I. NAME

The name of the corporation shall be Sharon C. Brannan, CPA PA

ARTICLE II. ADDRESS

The principal place of business and mailing address of the corporation shall be

ARTICLE III. DURATION

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State. This Corporation shall commence on January 10, 1996.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock on one class only, having a par value of \$1.00 per share.

ARTICLE V. INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE X. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be by the Board of Directors, proposed by them to the shareholders, and approved at a shareholder's meeting by a majority of the shares entitled to vote thereon.

ARTICLE XI. PURPOSE

The primary purpose is to provide a variety of financial accounting services for businesses and individuals.
