ARTICLES OF WOORESTATION OF

ARTICLE I. NAME

The name of this corporation shall be LAUREN ENTERPRISES, INC.

ARTICLE II. DURATION

The period of the corporation's duration shall be perpetual or until dissolved as permitted by law.
