ARTICLE I - NAME

The name of the corporation is INTERNATIONAL TRADE CONSULTING, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually.

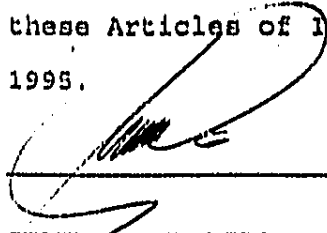

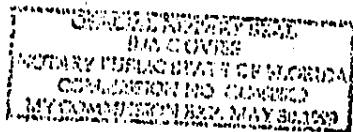
