OF WORKING COW, INC.



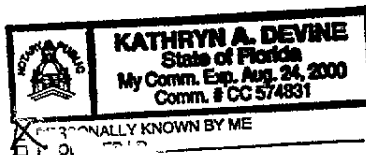
