ARTICLES OF INCORPORATION
OF
CHRIST'S TRUE LIGHT, INC.

ARTICLE I - NAME

The name of this corporation is CHRIST'S TRUE LIGHT,
INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in publication of religious materials and in any other activity or business permitted under the laws of the United States and of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is 2,500 shares of common stock, having a par value of \$1.00 per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be 2601 South Course Drive; #201, Pompano Beach, FL 33069, and the initial registered agent of this corporation at that address shall be Patricia Durham, who, upon accepting this designation, agrees to comply with the provisions of Florida Statutes Section 48.091, as amended from time to time, with respect to keeping an office open for service of process. ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial board of directors shall consist of one member. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one nor more than five. 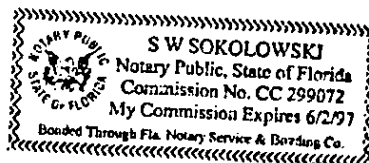
