ARTICLES OF INCORPORATION
OF
AJB INFORMATION SERVICES, INC.

ARTICLE I - CORPORATE NAME

The name of the corporation is
AJB INFORMATION SERVICES, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may hereafter be amended.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is TEN THOUSAND (10,000) shares of common stock having a par value of ONE DOLLAR (1.00)

ARTICLE V - TERM OF EXISTENCE

This corporation shall have perpetual existence, commencing upon filing of these Articles.

ARTICLE VI - REGISTERED AGENT AND INITIAL REGISTERED OFFICE

ARTICLE XI - AMENDMENT

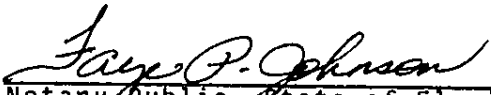

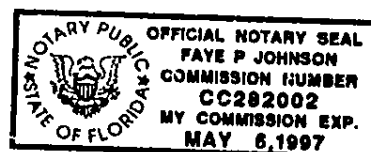
