

PUMPING, INC.

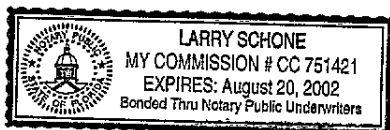
SECOND: The amendment was approved by a unanimous vote of the shareholders at a special meeting held March 1, 2002.
