The undersigned, for the purpose of forming a corporation for profit under the Florida C. FL General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I, NAME

The name of the corporation is: C A MILLER DESIGNS, INC..

ARTICLE II. DURATION

The term of existence of the corporation is perpetual.

ARTICLE III. PURPOSE
