The undersigned, citizens and residents of the State of Florida, in order to form a corporation pursuant to the laws of the State of Florida, do hereby certify:


1. The name of the corporation is "J.E.A. SERVICES, INC."
2. The general nature of the business to be conducted by the corporation is the commercial activity of providing equine services to the general public, buying and selling real and personal property, (or mixed), of whatever nature, and the general transaction of any and all lawful business.
3. The corporation shall have perpetual existence.
4. The corporation is authorized to issue two hundred (200) shares of common stock, all of which shall be without par value.
5. AIMEE VASQUEZ is hereby registered as the Registered Agent of the Corporation for all purposes, and the Agent to whom the Secretary of State shall send any process or any documents relating to the Corporation; the registered office of the Corporation, the principal office of the Corporation, and the office of the Registered Agent, AIMEE VASQUEZ, shall all be located at 14 Teak Course, Marion County, Ocala, Florida, 34472.
6. Until the first annual meeting of the shareholders, there shall be two Directors constituting the official Board: EFREN VASQUEZ and AIMEE VASQUEZ, both of whose offices are as hereinabove set forth, and they shall act as the Board of Directors for the first year of the Corporation's existence, or until the first annual meeting of Shareholders. Thereafter, there shall continue to be two Directors, or such other number as may be designated by the By-Laws.
7. The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.
8. This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any Amendment hereto, and any rights conferred upon the Shareholders are subject to this reservation.




