KNOW ALL MEN BY THESE PRESENTS, That the incorporator does hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be and is

FARRELL & STEEL, INC.

ARTICLE II

The duration of the corporation shall be and is perpetual, and the date and time of the commencement of the corporation's existence shall be and is the date and time these Articles of Incorporation are filed by the Department of State of the State of Florida.

ARTICLE III

The general purposes for which the corporation is initially organized are as follows:

- (a) To engage in the business of interior design for commercial businesses and enterprises in the State of Florida; and
