The undersigned subscribers to these Articles of Incorporation hereby form a corporation under Chapter 607, Florida Statutes.

#### ARTICLE I

NAME. The name of this corporation is LIPTON INSURANCE EXAMS, Inc.

#### ARTICLE II

NATURE OF BUSINESS.
