

ARTICLES OF AMENDMENT. TO ARTICLES OF INCORPORATION OF FLORIDA CAPITAL LAND CORPORATION



Pursuant to the provisions of Section 607.1006 of the Florida Statutes, FLORIDA CAPITAL LAND CORPORATION, a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:
