The undersigned incorporators to these Articles of Incorporation, natural persons competent to contract, hereby presents these Articles of Incorporation for the formation of corporation under the applicable laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be M.M. & U. TRUCKING, INC.

ARTICLE II

NATURE OF BUSINESS

The Corporation may engage in activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCKS

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is twenty (20) shares, all of which shall be voting common stock of the par value of One (\$1.00) Dollar. To the extent permitted by law, said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1954, as amended.

All of the said stock shall be payable in cash, or in services or property other than stock or securities, in lieu of cash, at a just valuation to be determined by the stockholders of this Corporation at a regular special meeting.
