# ARTICLES OF INCORPORATION OF DIANE COLONNELLO, L.C.S.W., P.A.

96 HAR -8 FN 3-32 TALLAHAM ELFLORIDA

The undersigned incorporator, who is licensed and legally authorized to practice clinical social work in the State of Florida and to perform the services of a clinical social worker in the State of Florida, with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following articles of incorporation for the corporation:

# ARTICLE I

#### NAME

The name of the corporation is DIANE COLONNELLO, L.C.S.W., P.A.

#### ARTICLE II

# PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is Suite 103, 1400 Royal Palm Square Boulevard, Fort Myers, Florida, 33919, City of Fort Myers, County of Lee, State of Florida. The name of the initial registered agent of the corporation, located at that office, is Diane Colonnello.

#### ARTICLE III

# DURATION

The period of the corporation's duration shall be perpetual until dissolved on a vote of the shareholders as provided in these articles.

#### ARTICLE IV

#### **PURPOSE**

The purpose of the corporation is to engage in the practice of clinical social work as a professional corporation and to carry on services incident to the practice of clinical social work. The practice of clinical social work is the sole and exclusive professional service to be rendered by this corporation. Additionally, the corporation shall have the authority to own property, enter into contracts and to carry on a business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation. Professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been duly licensed in, and is duly authorized to practice clinical social work in, the State of Florida.

#### ARTICLE V

# **BYLAWS**

The initial directors shall submit the proposed bylaws to the shareholders at a meeting to be held for that purpose. Following the adoption of bylaws, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.

# ARTICLE VI

# **ENDEMNIFICATION**

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

#### ARTICLE VII

# CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is 100 shares. These shares shall be of a single class of common stock, and shall have a value of \$1.00 per share.

# ARTICLE VIII

#### DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds (2/3rds) of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.
