ARTICLE I

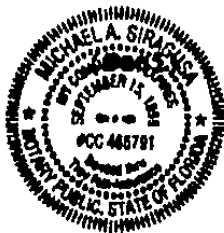

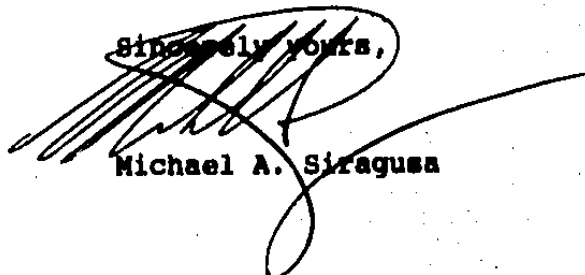
