ARTICLES OF INCORPORATION  
OF  
CAMPBELL'S AGAPE ALABAMA BAR-B-QUE, INC

The undersigned subscribes to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is: CAMPBELL'S AGAPE ALABAMA BAR-B-QUE, INC

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is: To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, kind, and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, fraternal benefit society, state fair or exposition.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is twenty-five thousand (25,000) shares with par value of one dollar (\$1.00) each; a total of twenty-five thousand (\$ 25,000).

ARTICLE IV

INITIAL CAPITAL

The amount of capital with which this corporation will begin business is Twenty-five Thousand Dollars (\$ 25,000).

ARTICLE V

TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI

ADDRESS

The initial post office address of the principal office of this corporation in the State of Florida is 4312 West Arch Street, Tampa, Florida 33607. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

ARTICLE VII

DIRECTORS

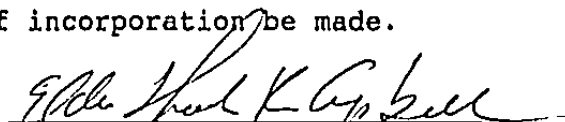
