**ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation.

TALLAHASSEE, FLORIDA

ARTICLE ONE. NAME

The name of the corporation is SWAMIJI, INC.

ARTICLE TWO. CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE. PURPOSES

The corporation is organized for all lawful purposes:

1. To have and to exercise all the power now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental hereto.

2. To do all and everything necessary, suitable, or proper for the accomplishment of any of the purposes, the attainment of any of the objects, or the exercise of any authority herein set forth, either alone or in conjunction with other corporations, firms, or individuals, and either as principal or agent, and to do all acts or things incidental or appurtenant to or growing out of or connected with the above-mentioned objects, purposes, or authority.

ARTICLE FOUR. CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000). Such shares shall be of a single class.

ARTICLE FIVE. PRINCIPAL AND REGISTERED OFFICE AND AGENT

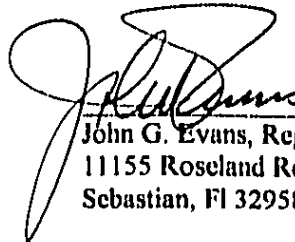
