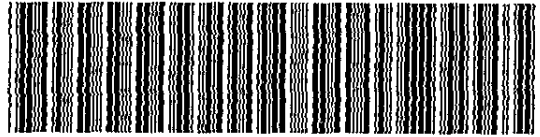

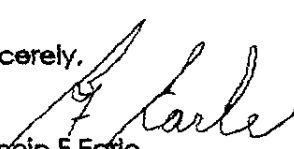
Please be advised that the above reference corporation has been dissolved, and has done no business since 12/31/02.
