

ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
SOUTHERN VITREORETINAL ASSOCIATES, P.A. SECRETARY OF STATE

Pursuant to the provisions of Sections 607.1006 and 621.13(4), Florida Statutes, this Florida professional corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I of the Articles of Incorporation as previously amended is amended to read:

**ARTICLE I**  
**Name and Principal Office**

*The name of this Corporation shall be **SOUTHERN VITREORETINAL ASSOCIATES, INC.** The principal place of business and mailing address of this Corporation shall be 2439 Care Drive, Tallahassee, Florida 32308-4580.*

2. Article II of the Articles of Incorporation is amended to read:


**ARTICLE II**
