ARTICLES OF INCORPORATION
OF

Article I - Name

The name of the corporation will be:

ATRIS TECHNOLOGY, INC.

Article II - Duration

The corporation shall have a perpetual existence, commencing on the date of filing of these articles with the Department of State.

Article III - Purpose

The corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue 7,500 shares of common stock which shall be designated "Common Shares".

Article V - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


